RE: Combination with Sacramento Suburban Water District

BACKGROUND

The combination discussion between Carmichael Water District (CWD or District) and Sacramento Suburban Water District (SSWD) began in July 2021 with the appointment of a 2x2 Ad Hoc Committee (Committee). To date, there have been 21 2x2 Committee meetings, 2 joint Board meetings, and 4 public information workshops, 2 held at CWD and 2 held at SSWD. Both districts have also jointly 1) conducted a Business Case Analysis by a third party consultant, 2) developed the *Further Analysis of Combining Carmichael Water District and Sacramento Suburban Water District* by staff from both organizations, and 3) retained facilitation services and public outreach consultants.

SUMMARY

The combination effort has been on-going for about two and a half years and the Board has discussed items including, but not limited to, water quality, water rights, governance, rates, and combination by other agencies, etc. CWD and SSWD have paid consultant services costs for the Business Case Analysis, public outreach, and facilitation of \$287,083.60, of which CWD's share is \$143,541.80. CWD's has also paid attorney service costs of \$49,521.83.

In addition to comments received at the two CWD Public Information Workshops and regular Board meetings, CWD has received 75 written emails and letters from CWD's rate payers, 44 emails from the American Federation of State and County Municipal Employees (AFSCME) union, 2 phone calls, and 1 employee petition stating its opposition and requesting the petition to be made public. Of the total 122 communications received as of 03/24/2024, 121 are in opposition of the combination and 1 is open to a combination. There are 25 full time employees excluding the General Manager, and 23 employees signed the petition in Attachment 1.

RECOMMENDATION

The Board of Directors approves continuing the process of evaluating the potential consolidation of CWD with SSWD.
